

- VI. Supplemental training workshop with the ARB's legal counsel. Some or all of the workshop may take place in an executive session pursuant to §551.071 of the Texas Government Code to discuss: pending or contemplated litigation; a settlement offer; a matter in which the duty of the attorney to the ARB requires confidentiality under Texas Disciplinary Rules of Professional Conduct of the State Bar of Texas.
- VII. Receive supplemental appraisal records for 2019-2024 tax years from the Chief Appraiser in accordance with Tax Code Section 25.23, including real property records, business personal property records and mineral and industrial property records

- VIII. Perform initial review of supplemental appraisal records submitted for 2019-2024 tax years per Tax Code Section 6.42(b), subject to ARB's determination(s) of any protest thereon
- IX. Approval of the Supplemental appraisal records submitted for 2019-2024 tax years per Tax Code Section 6.42(b), subject to ARB's determination(s) of any protest thereon
- X. Schedule date and time of next meeting
- XI. Adjourn
