

As authorized by Section 551.071 of the Government Code, this meeting may be convened into a closed executive session to obtain confidential legal advice from the Midland Central Appraisal Review Board's attorney on any agenda item listed herein. The Midland Central Appraisal Review Board will then

reconvene in an open session and take any action, as may be necessary, on any items discussed in a closed executive session.

Beginning on June 4, 2025, at 9 a.m. and continuing each business day until completed, panels of the ARB will be conducting hearings on protests and/or motions. Those hearings will occur in the Appraisal District's office and they are open to the public. With the exception of the meetings noted above, however, no meetings involving a quorum of the ARB will be held.
